MEMORANDUM

Sub : **Enhancement of Pension quota under Non-Plan and Enhancement of Pension rate under both Plan & Non-Plan**

In order to combat the price- hike of all the commodities and also to extend the facilities of financial assistance to the more destitute people of the economically weaker section of the society in West Bengal, the undersigned is directed, by order of the Governor, to say that the Governor has been pleased to accord sanction to the enhancement of monthly rate from Rs. 500/-per month to Rs. 750/- per month per head under both Plan & Non-Plan and also to the enhancement of 32,061 numbers of quota in addition to the existing quota, as detailed in the annexure on the reverse of this order, w.e.f 01.02.2009 under Non-Plan head of account.

2. The districtwise distribution of the enhanced quota of 32,061 for Disability Pension, Widow Pension and Old Age Pension is mentioned in the reverse of this order.

3. The enhanced financial involvement may be met from the Major head of A/C, " 2235-etc." as mentioned in the annexure on the reverse of this order under Demand No. 56, Departmental Code-SW, subject to observance of usual rules and procedures.
